Dear Parents and Guardians:

Our school division is informing parents and guardians of Lord Botetourt High School that a student has tested positive for coronavirus disease 2019 (COVID-19). We understand this news is concerning and want to share our efforts to keep students and staff safe, healthy, and in school. Lord Botetourt High School will remain **OPEN** during this time.

We are working closely with the Roanoke and Alleghany Health Department to identify anyone who had close contact with the positive individual. The parent of any student identified as having been potentially exposed will be contacted directly by the health department or school officials. Individuals who have been in close contact will be required to self-quarantine for 14 days from their last exposure to the positive individual. A negative test for COVID-19 during the self-quarantine time will not shorten the 14-day quarantine period.

The health department is reporting an increase in confirmed COVID-19 cases in our region. If you or a family member has been exposed to or diagnosed with COVID-19, please report this to your school. Individuals who are confirmed to have COVID-19 are asked to isolate themselves from others and to assist health and school officials with identifying close contacts who may have been potentially exposed.

Parents should continue to monitor their child's health and the health of their families for COVID-19 symptoms. Children with COVID-19 generally have mild, cold-like symptoms, such as fever, runny nose, and cough. Vomiting and diarrhea have also been reported in some children. Children with certain underlying medical conditions, such as chronic lung disease or moderate to severe asthma, serious heart conditions, or weak immune systems, might be at higher risk for severe illness from COVID-19. Contact your child's healthcare provider regarding any concerns. People without symptoms do not necessarily need to seek care or be tested. Those who become ill should contact their healthcare provider. Their doctor, in consultation with public health officials, will determine appropriate care and whether testing is necessary.

The areas impacted by the potential exposure were cleaned following established protocols, including the use of EPA registered disinfectants. Schools continue to utilize Center for Disease Control and Prevention (CDC) recommendations on [Reopening Guidance for Cleaning and Disinfecting Public Spaces](#), to reduce viral transmission and keep our children and school personnel healthy and safe. Parents and family members can assist this effort by promoting healthy behaviors and following these practices:

- Stay home from school or work if sick, even if symptoms are mild.
- Wear a face covering in areas where physical distancing is difficult to maintain.
- Cover coughs and sneezes with a tissue (or sleeve), and then throw the tissue in the trash. Immediately wash your hands with soap and water for at least 20 seconds.
- Wash your hands often with soap and water for 20 seconds. If soap and water are not readily available, use an alcohol-based hand sanitizer that contains at least 60 percent alcohol.
- Avoid touching the eyes, nose and mouth with unwashed hands.
- Clean and disinfect surfaces that are often touched.
- Avoid close contact with people who are sick.
- Take care of your health overall. Stay current on your vaccinations, including the flu vaccine, eat well, and exercise to help your body stay resilient.
